



Weekly Summary of Long-term Care Facilities With Residents or Staff Positive for COVID-19

Report posted Friday, June 19, 2020

As of June 19, 2020, there have been:

- Overall, 34 outbreaks with 323 total cases:
 - 21 facilities have resolved outbreaks.
 - 10 of the 21 resolved outbreaks included only 1 resident or staff member reported with COVID-19, and there was no further spread in the facility.
- 56 COVID-19-related deaths associated with nine facilities.
- Currently, 86 people reported with COVID-19 associated with 13 long-term care facilities.

For purposes of these data, the following definitions apply:

Long-term care facility means a nursing home, assisted living facility, or intermediate care facility. There are just over 400 long-term care facilities in Idaho.

Outbreak means at least one lab-confirmed COVID-19-positive case associated with a facility.

Probable Case means the person had symptoms of COVID-19 and was exposed to someone with a lab-confirmed case of COVID-19, but there is no positive laboratory test confirming COVID-19 infection.

Resolved means that more than 28 days have passed (2 incubation periods) without any additional cases associated with the facility.
