



Weekly Summary of Long-term Care Facilities With Residents or Staff Positive for COVID-19

Report posted Friday, July 24, 2020

As of July 24, 2020, there have been:

- Overall, 92 outbreaks with 849 total cases:
 - 29 facilities have resolved outbreaks.
 - 18 of the 29 resolved outbreaks included only 1 resident or staff member reported with COVID-19, and there was no further spread in the facility.
- 80 COVID-19-related deaths associated with eighteen facilities.
- Currently, 569 people reported with COVID-19 associated with 63 long-term care facilities.

For purposes of these data, the following definitions apply:

Long-term care facility means a nursing home, assisted living facility, or intermediate care facility. There are just over 400 long-term care facilities in Idaho.

Outbreak means at least one lab-confirmed COVID-19-positive case associated with a facility.

Probable Case means the person had symptoms of COVID-19 and was exposed to someone with a lab-confirmed case of COVID-19, but there is no positive laboratory test confirming COVID-19 infection.

Resolved means that more than 28 days have passed (2 incubation periods) without any additional cases associated with the facility.

The table on the following page provides a list of long-term care facilities with current or resolved COVID-19 cases. “Facilities with Ongoing Outbreaks” are listed in the order in which the outbreaks were reported to the Division of Public Health. “Facilities with Resolved Outbreaks” are listed in the order in which the outbreaks were declared resolved.
