

# Idaho COVID-19 Vaccine Advisory Committee (CVAC) Vaccine Prioritization

Updated: March 16, 2021

Idaho Governor Brad Little convened the Idaho COVID-19 Vaccine Advisory Committee (CVAC) to advise him on and assist state and local entities with the prioritization of vaccines when they are in limited supply, guide planning efforts and broadly communicate messaging to ensure equitable access to COVID-19 vaccines across the state.

The following vaccine prioritization ranking is based on federal recommendations, CVAC input, and Governor approval. It is subject to change as new information is available.

# Healthcare Personnel & Long-Term Care Facility Residents

The healthcare personnel category was first presented to CVAC 10/23/2020 based on the phased recommendations of the federal Advisory Committee on Immunization Practices (ACIP). CVAC has recommended to the Governor priority groups for administration of limited vaccine and the following is the current prioritization as approved on 2/22/21.

<b>Healthcare personnel (HCP)</b> (Includes clergy who enter healthcare facilities to provide religious support to patients)	1
Hospital staff essential for care of COVID-19 patients and maintaining hospital capacity (includes support staff, clinical staff, and medical imaging professionals)	1.1
Outpatient clinic staff essential for care of COVID-19 patients and maintaining hospital capacity (includes vaccine administrators and behavioral health workers, including counselors for substance abuse treatment centers and suicide prevention hotline workers)	1.1
Long-term care facility staff (includes staff of adult day care facilities and intermediate care facilities for individuals with intellectual disabilities)	1.2
Home care providers for adults ≥ 65 years of age, or for other adults/children with high-risk medical conditions (includes staff of certified family homes but does not include adult family members who provide in-home personal care for adults 65 years of age and older or for other adults or children with high-risk medical conditions)	1.2
Emergency Medical Services (EMS)	1.3

# Healthcare Personnel & Long-Term Care Facility Residents

CVAC has recommended to the Governor priority groups for administration of limited vaccine and the following is the current prioritization as approved on 2/22/21.

Outpatient and inpatient medical staff not already included above who are unable to telework (includes school nurses, Idaho National Guard medical staff, blood center workers, psychiatric residential treatment facility staff, radiation therapists, and optometrists)	1.4
Dentists, dental hygienists and dental assistants	1.5
Pharmacists, pharmacy technicians and pharmacy aides	1.6
Public health and emergency management response workers who are unable to telework (includes Idaho National Guard deployed to support public health response, state and local public health COVID-19 responders who are unable to telework)	1.7
<b>Long-term care facility residents</b> (Includes residents of long-term care facilities within correctional or detention settings, residents in certified family homes, and participants in group adult daycare programs)	1

Idaho Group 3 (ACIP 1c) was first presented to CVAC on 2/19/2021 based on the recommendations of ACIP and the Centers for Disease Control and Prevention. CVAC has recommended to the Governor priority groups for administration of limited vaccine and the following is the current prioritization as approved on 3/15/2021.

<b>Age plus Medical Condition alternating with Age Bands</b> <i>Medical conditions are defined as “are at increased risk” and “might be at increased risk” per the CDC. Age 16-44 with at least one medical condition   Open April 12 <sup>th</sup> **	3.5
Age 16-44 general population   Open April 26 <sup>th</sup> **	3.6
