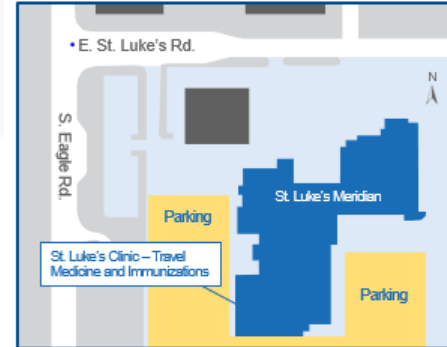
COVID-19 Vaccination Locations



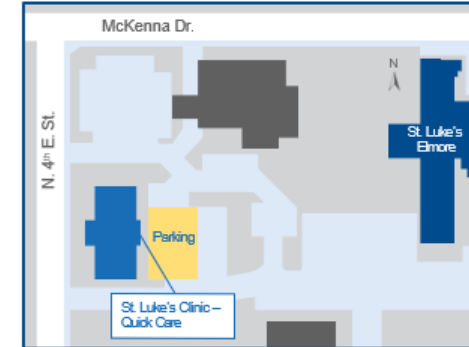

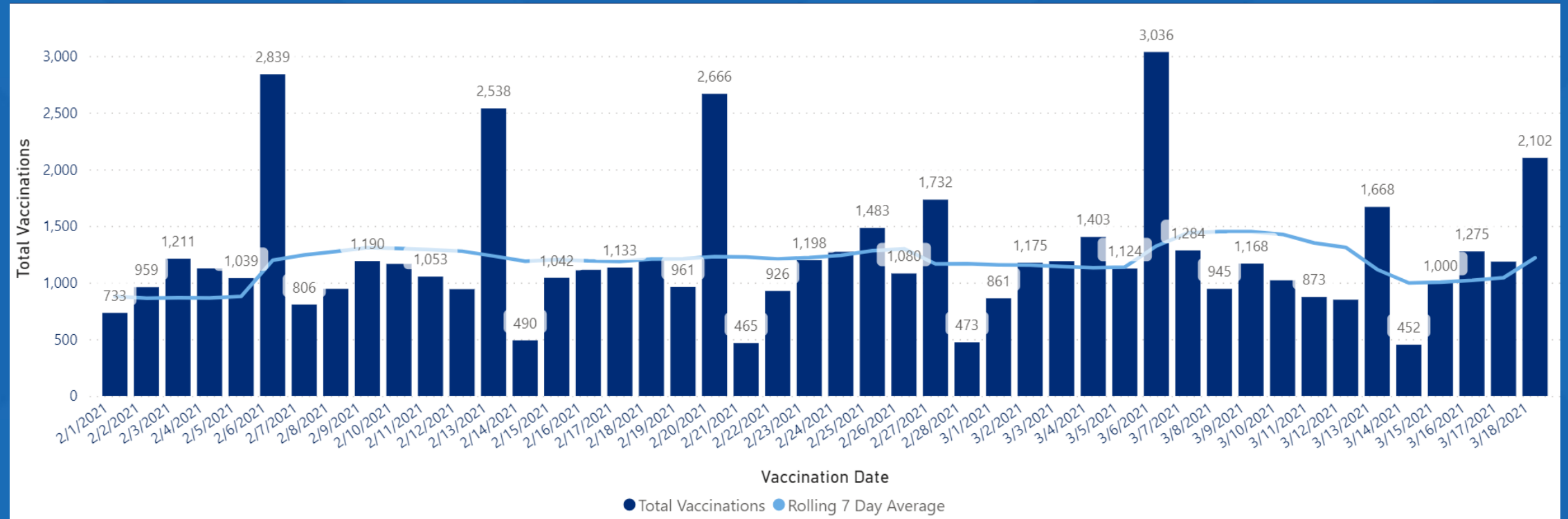
