



Weekly Summary of Long-term Care Facilities With Residents or Staff Positive for COVID-19

Report posted Friday, October 14, 2022

As of October 14, 2022, there have been:

- Overall, 370 facilities with outbreaks with 18,785 total cases:
 - 292 facilities have resolved outbreaks.
 - 8 of the 292 resolved outbreaks included only 1 resident or staff member reported with COVID-19, and there was no further spread in the facility.
- 1,180 COVID-19-related deaths associated with 239 facilities.
- Currently, 6,824 people reported with COVID-19 associated with 78 long-term care facilities.

For purposes of these data, the following definitions apply:

Long-term care facility means a nursing home, assisted living facility, or intermediate care facility. There are just over 400 long-term care facilities in Idaho.

From 3/13/20 – 5/31/22, “*Outbreak*” means at least one lab-confirmed COVID-19-positive case associated with a facility.

From 6/1/22 – present, “*Outbreak*” means at least one facility-acquired COVID-19 infection in a resident, or two or more COVID-19 infections in healthcare personnel who worked in the facility during their exposure or infectious period.

Probable Case means the person 1) tested positive for SARS-CoV-2 infection using an antigen test, 2) they have a clinically compatible illness and epidemiologic risk for infection, or 3) their death certificate lists COVID-19 or SARS-CoV-2 as an underlying cause of death or significant condition contributing to death, without confirmation using a molecular amplification test

Resolved means that more than 28 days have passed (2 incubation periods) without any additional cases associated with the facility.

The table on the following page provides a list of long-term care facilities with current or resolved COVID-19 cases. “Facilities with Ongoing Outbreaks” are listed in the order in which the outbreaks were reported to the Division of Public Health. “Facilities with Resolved Outbreaks” are listed in the order in which the outbreaks were declared resolved. If an outbreak was previously resolved and then reopened, the facility has been removed from “Facilities with Resolved Outbreaks” list and added back to the “Facilities with Ongoing Outbreaks” list. For these facilities, the number of cases and number of deaths reflect the cumulative total of all outbreaks. Data subject to change as counts are updated.
