



Weekly Summary of Long-term Care Facilities With Residents or Staff Positive for COVID-19

Report posted Friday, September 01, 2023

As of September 01, 2023, there have been:

- Overall, 373 facilities with outbreaks with 25,179 total residents and staff.
- 1,300 COVID-19-related deaths associated with 244 facilities.
- Currently, there are 553 people reported with COVID-19 associated with 46 long-term care facilities.

For purposes of these data, the following definitions apply:

Long-term care facility means a nursing home, assisted living facility, or intermediate care facility. There are 384 long-term care facilities in Idaho.

From 3/13/20 – 5/31/22, “*Outbreak*” means at least one lab-confirmed COVID-19-positive case associated with a facility.

From 6/1/22 – 05/11/23, “*Outbreak*” means at least one facility-acquired COVID-19 infection in a resident, or two or more COVID-19 infections in healthcare personnel who worked in the facility during their exposure or infectious period.

From 5/12/23 - present, “*Outbreak*” means at least two COVID-19 infections in residents and/or healthcare personnel diagnosed within 14 days of each other. Resident cases are counted towards an outbreak if they resided in the facility during their exposure or infectious period. Healthcare personnel cases are counted towards an outbreak if they worked in the facility during their exposure or infectious period.

Probable Case means the person 1) tested positive for SARS-CoV-2 infection using an antigen test, 2) they have a clinically compatible illness and epidemiologic risk for infection, or 3) their death certificate lists COVID-19 or SARS-CoV-2 as an underlying cause of death or significant condition contributing to death, without confirmation using a molecular amplification test

Resolved means that more than 28 days have passed (2 incubation periods) without any additional cases associated with the facility.

“Facilities with Ongoing Outbreaks” are listed in the order in which the outbreaks began. “Facilities with Resolved Outbreaks” are listed in the order in which the outbreaks were resolved.
