



## Weekly Summary of Long-term Care Facilities With Residents or Staff Positive for COVID-19

Report posted Friday, October 20, 2023

As of October 20, 2023, there have been:

- Overall, 374 facilities with 26,288 total residents and staff who have had COVID-19 infections.
- 1,310 COVID-19-related deaths associated with 244 facilities.
- Currently, there are 1,053 people reported with COVID-19 associated with 87 long-term care facilities.

For purposes of these data, the following definitions apply:

*Long-term care facility* means a nursing home, assisted living facility, or intermediate care facility. There are 384 long-term care facilities in Idaho.

From 3/13/20 – 5/31/22, “*Outbreak*” means at least one lab-confirmed COVID-19-positive case associated with a facility.

From 6/1/22 – 05/11/23, “*Outbreak*” means at least one facility-acquired COVID-19 infection in a resident, or two or more COVID-19 infections in healthcare personnel who worked in the facility during their exposure or infectious period.

From 5/12/23 - present, “*Outbreak*” means at least two COVID-19 infections in residents and/or healthcare personnel diagnosed within 14 days of each other. Resident cases are counted towards an outbreak if they resided in the facility during their exposure or infectious period. Healthcare personnel cases are counted towards an outbreak if they worked in the facility during their exposure or infectious period.

*Probable Case* means the person 1) tested positive for SARS-CoV-2 infection using an antigen test, 2) they have a clinically compatible illness and epidemiologic risk for infection, or 3) their death certificate lists COVID-19 or SARS-CoV-2 as an underlying cause of death or significant condition contributing to death, without confirmation using a molecular amplification test

*Resolved* means that more than 28 days have passed (2 incubation periods) without any additional cases associated with the facility.

“Facilities with Ongoing Outbreaks” are listed in the order in which the outbreaks began. “Facilities with Resolved Outbreaks” are listed in the order in which the outbreaks were resolved.
